Purpose and Powers

Promote, sponsor and carry out broader opportunities and services for the benefit of students, faculty, staff and alumni of Troy University.

Powers

- Provide members with services determined by the board as necessary or desirable.
- Encourage gifts, grants, loans, devises and bequests of all types of property.
- Receive, hold, own and administer such property.
- Primary object- serving needs of members and Troy University.
- Become party to contracts of every type.
- Purchase, use, mortgage, pledge, lease, sell and otherwise dispose of property.
- General advancement of educational environment of Troy University.
- Have and exercise all rights, powers and privileges of a non-profit corporation as provided by the Code of Alabama.

Three Classes of Members

- Regular Members: are duly elected or appointed by virtue of being members of UAC.
- Associate Members: Consists of students, faculty, staff or alumni of Troy
- Community Members: Consists of those in the surrounding Troy area who wish to participate in special classes or trips sponsored by CSI.
